PUBLIC HEARING CITIZENS CORRESPONDENCE PERSONAL APPEALS: Charles Beck: 1511 Legrande Street, having a problem with water draining and filling up his yard. DPW has been out there a number of times to keep up with it.

Fred Gause: 333 S. Mercer Street. Wise Chip factory. Still having problems with tractor trailers using Mercer Street to enter instead of Poplar Street and has a tractor trailer blocking his driveway and his neighbor's driveway. He called 911 and an officer showed up and saw what he was talking about. Councilman Jarrett suggested an Ordinance for no truck traffic on Rasley Street, S. Mercer and S. Warren Streets. He advised Mr. Gause that it may take a few months to get this completed. And maybe Wise will put up some signs also. Mayor Burke said that Wise was open to that suggestion when he last spoke to them. The Solicitor will work on the Ordinance in order to have sign put up.

Joe Buffone Sr.: 1652 Steel Street. Has noticed that upper Steel Street between Eaton & Scanlon Streets. The Water Company has not been back to work in about 2 weeks that road is so far off grade by at least 12

inches. It is all sloped. It is a mess. Wants to know what the plan is for that street as it needs to be graded. Jack Kyttle said that work is not complete yet. But they will not grade the street as that is not in their scoop. And years ago they crowned the road to get the water off the roadway. It is not on our road list at this time. Jack will call him with some ideas he has that may help. Councilman Talanca suggested putting it on the road listing and Jack agreed to do that.

Bridgett Coolbaugh: Reliance Fire Company. Just wanted to say that combining National Night Out and Kids Night was a success and went well. She said we should continue to combine the events. She has spoken to Police Chief Strish and he was on board. Council agreed it was a good idea. She had a volunteer that would be willing to do free food for the kids that attend. National Night Out is always the first Tuesday in August. Clubs and organizations can count on the date in August.

Bo Orlando the Berwick School District's Athletic Director said the School is on board and he has a call out to the Fire Chief Randy Remphrey for a fire truck to be in attendance. Councilman Jarrett made a motion to allow the Berwick Area School District's Spirit Club hold a Bond Fire this Friday night August 23, 2019. With the agreement that a fire truck will be on hand for an emergency. This was seconded by Councilman Talanca. All ayes. Motion passes.
