PERSONAL APPEALS: Resident Carl Ferrious of 1925 Fairview Ave, with regard to the trucks using Berwick public streets for access to farmland at the end of Fairview Ave dead end. NEW BUSINESS:

1. Consider and take action on tentative CDBG allocations for Council's approval; TYLER DONBROSKI SEDA-COG:

Tyler Dombroski from SEDA-COG said that for the 2016 CDBG program; 4 project have been tentatively approved. They are as follows:

> Senior citizen home owner's sidewalk rehabilitation \$50,000.

- > Demo of some properties around the Borough \$50,000.
- ➤ Reconstruction of Grant Street \$25,000. this is in addition to the previous amount of \$100,000.
- ➤ Reconstruction of Pearl Street \$125,000. With an additional \$4,721. Added as administration cost for SEDA-COG came in under what was previously thought so the overage of \$4,721 was added to Pearl Street project.

Administration cost for SEDA-COG came out to be \$42,593. Tonight Council will vote to approve this tentative allocation.

<u>Discussion</u>: Council asked if money could be moved around. For example on Pearl Street the Sewer authority will be doing part of Pearl Street. Tyler said yes you can move the money to other projects.

MOTION made by Councilman Jarrett and seconded by Councilman Bower. All Ayes, motion passes.

2. Consider and take action to make the older white street signs available for sale to interested residents. Cost is \$10.00. Discussion: NONE

MOTION made by Councilman Jarrett and seconded by Councilman Shecktor. All Ayes, motion passes.

3. Consider and take action on charges for the use of Test Track Park for events. Discussion: NONE

MOTION to table issue made by Councilman Bower and seconded by Councilman Shecktor. All Ayes, motion tabled.

4. Consider and take action on the Garibaldi sidewalk issue.

<u>Discussion</u>: Our engineer said it was BAJSA fault that the curbing/sidewalk is dropping. After talking to the older retired employees of the sewer authority I found out that between 1997-2000 that street was rebuilt down there with CDBG funds. There was a dry well put in down there right outside the Garibaldi where the sidewalk and curb is dropping. Garibaldi offered to pay for the concrete if we pay the labor costs to take care of the 6 sidewalk sections and curb. Councilman Shecktor asked for a cost? It would take DPW about 2 days to complete the work.

MOTION made by Councilman Shecktor and seconded by Councilwoman Huntington. All Ayes, motion passes.

5. Consider and take action on the purchase of DVR cameras for the Veterans Memorial Fountain and Ber-Vaughn Park at an approximate cost of \$1,800.00. The purpose would be to discourage vandalism.

<u>Discussion</u>: This would be taken out of the PPL fund and not the general fund. Cheaper options would be 1 camera and you could ever add to it and records for only 90 hours of video and then recycles for \$750.00 for 1 camera. 1 camera at Veterans Park and replace DVR at Ber-Vaughn for \$500. This is a better system with a clearer picture and zoom capability and you can add cameras to the system.

MOTION made by Councilman Jarrett to go with the better camera system and seconded by Councilman Meighan. All Ayes with Councilman Petty opposed, motion passes.

6. Consider and take action on The Berwick Area Swimming Pool Association pledge of \$10,000.

<u>Discussion</u>: Councilman Shecktor said that he was in discussions with the pool association prior to coming onto council and feel we are 100% obligated to that and it is the right thing to do. I have one concern with regard to pricing, I think we should consider to put more into it to do something to bring pricing down for our residents.

MOTION made by Councilman Shecktor and seconded by Councilman Jarrett. All Ayes, motion passes.

7. Consider and take action on Ranger Hose Engine. Discussion: NONE

MOTION made by Councilman Shecktor and seconded by Councilman Petty to put it out for bid. All Ayes, motion passes.

8. Consider and take action on pavilion rental fees. In the past, the collected fees have been put in a fund for pool maintenance. Moving forward, the collected fees will be used towards pavilion maintenance.

Discussion: This was set up in the beginning to benefit the

pool. This money should go back into the park for maintenance. There is \$8,000. In there right now from the last 4 years.

MOTION made by Councilman Meighan and seconded by Councilman Bower to move the money to a park maintenance fund. All Ayes, motion passes.

ADDED ITEMS:

(a.) Re-Adoption of Resolution 2016-05 regarding amplified music, this needs to be renewed every 30 days until the application to the PLCB is submitted.
