Attorney Kepner said he felt the borough would brought into the suit. He was then asked if the posting of a sign that states it finger printing was voluntary would alleviate a law suit and he said yes he felt it would.

# DISCISSION:

# **Councilman Petty:**

Our process violated the Civil Service rules that we promulgated, namely rule 4.17 which requires that the background checks be conducted by the Chief of Police or the Chief's designee. Council through our own vote supplanted that and had our own designee do the background check. So it appears by the letter of the rules we did violate the process as described in the Civil Service Rules.

#### **Councilman Jarrett:**

Was there in fact a vote of Council because I don't remember that.

# **Councilman Petty:**

Jay I can't remember every single vote that was taken, I remember that at some point it was at least discussed in a public meeting. I have to imagine that at some point we voted for an outside company to handle the whole process. I'm not going to speak for everyone but I would assume that the backgrounds were included in that process.

# **Councilman Jarrett:**

I will refresh your memory. In October we voted to have Mr. Gamble do the written, the oral and the physical agility. I believe that is what the motion said. And there was a conservation around this table that Chief Strish would do the background checks. It was not in the motion or in the minutes. But there was a conservation at this table.

# The Mayor

Do we have a \$30,000. Dollar waste here is that what we have?

# **Councilwoman Huntington:**

What about the hiring of Kyle James.

# **Councilman Petty:**

That is 2 issues that we need to take one at a time.

First we need to table this hiring and give the Chief a chance to conduct the background checks. In speaking with the Civil Service Attorney it will not impede on the process. So anybody that has been disqualified as a result of their determination or the polygraph will remain disqualified. All this does is give the Chief of Police an opportunity to ensure that the people on this current list are appropriate to be working in the Berwick Police Department. Another option that the attorney gave is that the Chief accepts the background that has already been conducted and waves his right and appoint whoever did the background as his designee it will get 2 cops on the street faster. He asked for the Chief input.

#### **Chief Strish:**

Yes, we need to get police on the street for the safety of my men and the citizens. I just need to see the materials, I need to see how they were vetted, and I need that material ASAP and then I'll make that decision as to whether I wave that.

There are 3 candidates here that I can do in a day and a half.

# **Mayor Burke:**

Mr. Kepner can we go back after we violated the policy and procedure manual?

# **Attorney Kepner:**

Yes, I think you can.

#### **Councilman Petty:**

I don't see any reason why we can't cure that violation by conducting another background check. Nowhere in the rules does it say you can only conduct one background check.

## **Attorney Kepner:**

I agree.

# **Councilman Petty:**

I do think after that background; regardless of what Chief Strish decides as to the designee, this will need to go back before the Civil Service Commission. If Chief decides to appoint t these people as his designee I don't think it will need to go back before the Commission because they already had the information and that is how they made their determination.

#### **Attorney Kepner:**

I would concur completely.

# **Mayor Burke:**

Mr. Kepner what if the Chief decides he does want to do the background seconded handed?

#### **Attorney Kepner:**

Then he has the right, under the Ordinance to do the background check.

# **Mayor Burke:**

Then this get thrown out.

# **Attorney Kepner:**

No Mr. Mayor, he could if he feels it is appropriate he could just go ahead and do the background checks. And then we will be in compliance with what the Ordinance says.

#### **Mayor Burke:**

And if chooses not to?

#### **Councilman Bower:**

Then he gets no cops.

# **Mayor Burke:**

I understand that but where does the right and wrong come in? We have to stop correcting.

#### **Council President Hill:**

What is the feeling Council? Motion to table the hire until Chief can do the background checks?

A motion was made by Councilman Bower to table the hiring until the Chief Strish reviews the background checks. This was seconded by councilman Petty. All ayes, one opposed (Councilwoman Huntington). Motion to table passes.

**Councilwoman Huntington:** I want Debra (Force) to speak of something that happened that Council should know about.

**Debra Force:** Last summer I was approached by Mr. Jarett and the Chief in order to share the applications with the Chief. Ken looked over each and every application. And Jay said this is how it has to be done. He needs to know what he is working with.

**Councilman Jarrett**: Said he will pick his words carefully. That Debra lied in a public meeting last month about what I said about Mr. Kepner.

**Debra Force**: No I did not.

**Councilman Jarrett**: Yes, you did. The incident you are referring to is the day we met with LCC. Correct, Chief? (Chief did not remember). What I said was that you two need to start working together. Because you have 7 common enemies; those of us around this table.

**Debra Force**: No, that is not the conservation you had with me. What you told me was that you, Ken and I have 1 common enemy. And that is Alvin Hill.

**Councilman Jarrett**: Well, that is true too. But that is another story. We can sit here and do a he said, she said.

**Debra Force**: Well, there is more. Kyle James. His physical agility testing wasn't moving fast enough for you and Ken. So you had me call Mr. DiPippa who did the testing prior. That was hiring an outside consultant.

**Councilman Jarrett**: Kinda like the attorney you hired.

**Debra Force**: That was with Council's consent. That was discussed at many workshops.

Council President Hill: Moving on.

**Councilwoman Huntington**: Tell the rest of it Debra.

**Debra Force**: You call me on August 24 (2015) at 4:30pm. You wanted me to witness the physical agility testing.

**Councilman Jarrett**: We did. Yes, we did witness the physical agility testing to get a cop on the street. We did not perform the testing.

**Debra Force**: No, Mr. DiPippa did (the testing). And I told you don't you ever put me in that position again.

**Councilman Jarrett**: Debra, let's get it on the table. You have alienated Chief Strish, Attorney Kepner and now myself because we have challenged you.

**Debra Force**: If I have alienated these 3 people it is because I am doing the work that council has asked me to do. I bring everything before council and that is why you don't like the way I work.

**Chief Strish**: My statement is this where does it say in the rules that the Borough Manage is in charge of anything regarding Civil Service. We have to follow rules; I have to follow rules as a Police Chief.

ADDED ITEMS: Fire engine bid opening. There were 2 bids. One from KME Kovach for \$523,661.00 and Ferrara for \$432,299.00. Motion by Councilman Petty to table the bids and review them to see why the big discrepancies in price and have a council member sit in on the review; one council member that is not affiliated with any fire company. This was seconded by Councilman Bower. All ayes. Motion to table passes. Councilman Schecktor was asked to sit in on the review.
