PERSONAL APPEALS: Berwick resident Peggy Bafile on 719 Sycamore Street. Still having problems with Mrs. Tuzzi feeding the birds scraps from the bakery. Now saying it not just bread but Danish, pizza and pie fillings. Councilman Bower said for Codes to send Mrs. Tuzzi to stop feeding the birds or be cited.

Cynthia Hollingshead-Stewart property owner of 121 E. 13th Street. Requesting the un-named alley behind her property be opened. The un-named alley is over grown with trees and has not been
