The Festival portion of Berwick Riverfest runs, **Friday 12pm – 9pm, Saturday 10:00am – 9pm, Sunday 10am – 6pm.** All vendors must be completely set up two hours before the event starts each day. All food vendors must provide proof of insurance of at least \$50,000 in liability coverage and all crafters/info stands must sign a hold harmless waiver. ***Please fill out this form completely, enclose the fee, proof of insurance or hold harmless waiver, and submit to address below.***
